History of the Forum

February 1996 - Vice President Al Gore held a meeting with leaders from the pharmaceutical industry, community advocates and government officials to discuss further steps in the development of ARVs to determine the best uses and long-term effectiveness of these drugs

 At Al Gore's request, the Keystone Center held a series of meetings between representatives from the pharmaceutical industry, public and private payors, healthcare delivery system groups, government agencies, patient advocacy groups and clinical research centers to discuss HIV medical management issues and the development of a framework for collaboration FO

History of the Forum

As a result of these meetings, a report was generated proposing the development of a project to continue the discussion amongst all of the stakeholders regarding the development of long-term strategies for the optimal use of ARVs for HIV infection

 The report was presented to AI Gore on August 2, 1996 with a recommendation that such work and guidance continue through the creation of the Forum for Collaborative HIV Research
