Introducing the Hepatitis B Screening and Vaccine Advisory Council

- •Aligning and implementing the new screening and vaccination recommendations will require concerted national effort with collaboration among various stakeholders

Advisory Council Summit: 2022

Summit Goal: Encourage the prioritization and implementation of updated hepatitis B vaccine & proposed screening recommendations for adults amongst healthcare providers

Objectives:

- •Discuss and evaluate challenges, opportunities, and best practices to implement universal adult hepatitis B vaccine recommendations across various stakeholder groups, with consideration of implementation complexities and challenges
- •Identify strategies for the implementation of vaccination and screening recommendations for adults

Outcome: Build the foundation of several strategies for implementation of recommendations; write and publish a white paper for use as a national guide for providers

Identified Challenges: Overview

- •There are different but overlapping challenges in every setting: primary care, hospital, pharmacy, harm reduction
- Lack of awareness across providers and communities
 - Provider confusion about hepatitis B vaccines, and who they should be used for
- Lack of system capacity and policies to implement recommendations
- Possible complexity of coordinating screening and vaccination
- •Billing, coverage and reimbursement
- •Well-known access (cultural/linguistic/transportation/navigation) barriers among high-risk communities and their providers, including vaccine hesitancy



Key Learnings

- EMR is critical for implementation in primary/health systems settings
 - Standing orders can play a key role
 - Need internal champions and tools for systems support to optimize implementation
- Providers will need clear, simple guidance especially about coordination of screening and vaccination
- Need to ensure engagement with health departments and community groups (and define roles)
 without over-burdening
- Supply & Demand
 - Community-based, not widespread
- Can leverage COVID-19 infrastructure and capacity
- There is a role for policy and advocacy
 - Funding for screening and vaccination
 - Pharmacy and harm reduction settings
 - USPSTF




Next Steps
