Principle 1. You can't always take sex out of conception

- Even if the patient's goal is conception, the provider's goal is to ensure whole health... that includes healthy sexuality and eroticism.
- People living with HIV are sexual beings
- If a discussion about conception *minus* sex is happening, it's important to start with understanding why eg.
- --> same gender loving?
- --> fertility concerns?
- --> individual vs couple.

HIV infected serodiscordant couples can reduce the risk of transmission by 96% to their partners by initiating oral antiretroviral therapy (ART) when their immune systems are still relatively competent, according to the HIV Prevention Trial Network (HPTN 052) results. Principle 2. Motherhood is a socially valued identity

- -Increasingly "parenthood"
- -For many WLHIV, motherhood may be the only socially valued identity available to them (Barnes, et al 2009).
- Critical for providers to understand motivation, including cultural factors related to conception for PLHIV



HIV Criminalization

EVEN IN STATES WITHOUT AN "HIV-SPECIFIC" STATUTE,
PEOPLE WITH HIV ARE AT RISK OF PROSECUTION UNDER OTHER CRIMINAL STATUTES.



SERG

Surveyed > 2000 U.S. PLHIV

- HIV criminalization is a significant deterrent to testing, accessing care, and treatment for HIV.
- 41% felt it could be reasonable to avoid treatment for fear of prosecution
- Almost half (49.6%) felt it could be reasonable to avoid testing for HIV for fear of prosecution
- One quarter (25.1%) of respondents reported they knew at least one person who told them they did not want to get tested for fear of prosecution if they tested positive
