Improving the health outcomes of people with HIV through earlier access to care and treatment is one of the primary goals of expanded routine HIV screening. Effective programs begin with successful linkages to and engagement in HIV care and are sustained by retaining people with HIV in care and optimizing use of antiretroviral therapy.
